4. THE DEFINITION OF A NORMAL PICKUP: PRODUCT IS PACKAGED TO MEET DOT STANDARDS AND AVAILABLE AT A LOADING DOCK WITH A PALLET JACK OR FORK LIFT AVAILABLE TO LOAD THE PRODUCT INTO TRAILER.
5. MK BATTERY RESERVES THE RIGHT TO REFUSE ALL UNAUTHORIZED RETURNS AT THE EXPENSE OF THE SHIPPER.
6. MK BATTERY WILL NOT ACCEPT ANY FREIGHT CHARGES BILLED BY THE SHIPPER TO MK FOR RETURNING SPENT BATTERIES.
